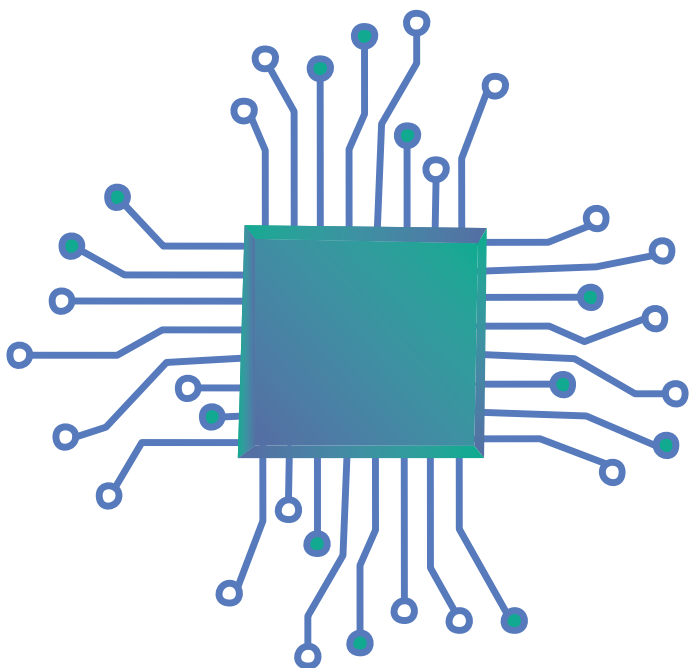

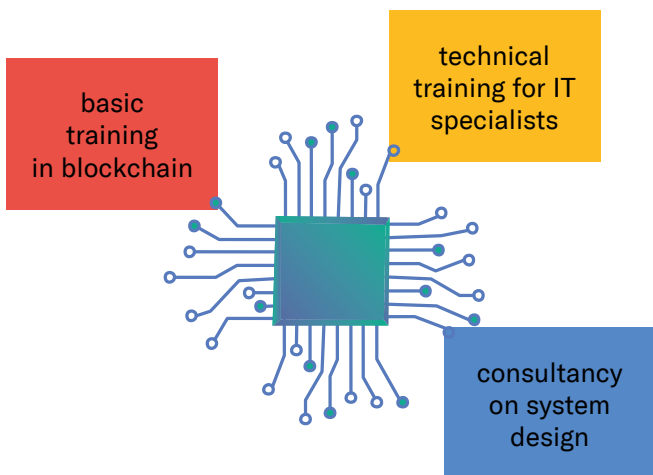
Blockchain
