Who are whistleblowers?

Whistleblowers are individuals who report or publicly disclose information on breaches of law in certain areas, obtained in connection with their work.

EU Member States, including Poland, are obliged to transpose into national law the solutions provided for in Directive (EU) 2019/1937 of the European Parliament and of the Council by 17 December 2021.

New obligations for enterprises




Introduce an internal whistleblowing policy setting out an internal procedure for reporting breaches of law and undertaking follow-up activities.

Protect whistleblowers and introduce antiretaliation measures.



Introduce an internal reporting channel and appoint an impartial person or a department to take steps in connection with the reported irregularities.
